## **ABOUT OUR PROGRAM**

The Before and After School Programs at United Faith Christian Academy are designed to meet the needs of working families who have students enrolled in Transitional Kindergarten (TK) through 12<sup>th</sup> grade at UFCA. We seek to offer nurturing, Christ-centered care for our students. The program is conveniently located on campus.

Before School Care is provided in the Gymnasium for all students (TK-12th grade).

The Falcon's Nest After School Program (TK-5th) complements, rather than duplicates, the school day by giving students the opportunity to relax and unwind while playing sports and games, socializing, and working on homework assignments with assistance from our after school staff.

After School Study Hall (6th-12th) offers students an opportunity to strengthen time management skills by providing dedicated time to address school work in a supervised setting. Students staying until 6:00 pm also have the opportunity for social interaction with peers.

## **PICK-UP**

Parents must come into the building or to the playground between 3:10 pm – 6:00 pm in order to sign their child(ren) out from the program each day.

**Late Pick-up:** A fee for late pick-up will be charged at \$1.00 per child for every minute past 6:00 pm. Excessive late pick-ups will result in a child being ineligible to remain in the program.

## **REGISTRATION FEES**

**\$50 for the first child  
\$25 for each additional child**

The non-refundable registration fee, per school year, secures your child's place in the program. This fee is additional and separate from the cost of the program. Each child must be registered prior to using the program. Registration and fee are online at [ufca.org](http://ufca.org) in the Parent Portal tab.

## **OTHER FEES**

**Insufficient Funds:** A \$30 charge will be added to the family's monthly account for insufficient funds.

**Delinquent Fees:** Delinquent payment (beyond 30 days) will result in the child being ineligible to remain in the program.

## **PROGRAM FEES**

We provide your family flexibility in choosing a plan that best fits your needs. Families can choose an unlimited plan or a pay-as-you-go plan for before and/or after school.

**Before School Only  
TK - 12th  
(7:00 am – 7:35 am)**

Monthly Family Plan \$60:

Unlimited AM days per month for one child. Additional children are \$30/month per child.

**After School Only  
(3:10 pm – 6:00 pm)**

Monthly Plan \$320: Unlimited PM days per month for one child. Additional Children are \$160/month per child

**Before and After School**

Monthly Plan \$380: Unlimited before and after school care per month per child. Additional Children are \$190/month per child.

**Drop-In Use**

AM - \$5/hour per child billed in hourly increments.

PM - \$8/hour per child billed in hourly increments.

Drop-In Use is billed separately on a monthly basis based on actual usage.
